The Environmental Protection Department and the EcoPark Management Company form the Selection Committee to assess the nominations based on the judging criteria, and to award each successful nominee.

Adjudication Scopes

Waste Reduction	<ul style="list-style-type: none">• adopts proper and effective waste management strategies and puts reduce, reuse and recycle into practice in normal operation (e.g. reduce paper use)
Waste Recycling	<ul style="list-style-type: none">• partners with the EcoPark tenants through sustained provision of waste sources• provides continuous assistance to the EcoPark tenants in their waste recycling activities• supports regular use of recycled products manufactured by the EcoPark tenants
Caring for the environment	<ul style="list-style-type: none">• adopts environmentally-friendly and sustainable practices in the daily operation (e.g. regular use of recycled or environmentally-friendly materials and products)• is awarded green certification(s) (e.g. ISO 9001:2008, ISO 14001:2004, OHSAS 18001:2007 and Hong Kong Awards for Environmental Excellence, etc.)
