

"Friends of EcoPark" bestowed with certificates

The development of the environmental and recycling industry calls for all stakeholders to work hand in hand to pave the way for sustainable solutions. The establishment of the "Friends of EcoPark" scheme is based on this principle with a view to advocating co-operation between various business sectors and the recycling and environmental industry in EcoPark.

On 17th May 2011, 49 "Friends of EcoPark" awardees were the first being honoured for their continuing effort in supporting EcoPark tenants to operate their recycling business and helping the tenants solving their operation problems by the Environmental Protection Department in a presentation ceremony.

EcoPark has, since its commissioning, been changing the city's long-existing management practices of "bale-and-export" for recyclable materials, namely packing and shipping our recyclable materials elsewhere for final disposal. It works with all segments of the private and public sectors to look for ways to promote the local recycling industry and jump-start a circular economy by encouraging and promoting the reuse, recovery and recycling of our waste resources and return them to the consumption loop. The goal is to alleviate the heavy reliance on the export of the recyclable materials recovered from Hong Kong.

Development of EcoPark is not easy in Hong Kong. The recycling industry practitioners have to face the difficulties of unstable waste source supplies, cost effectiveness, limited market demands for output products made from the recycled

materials plus many other market constraints. Owing to the support of the public community and relentless effort of the EcoPark tenants, the development of EcoPark is beginning to enjoy its first taste of success. The six lots in EcoPark Phase 1 have been let out to six local recycling companies for the recycling of various recyclable materials. Among which, five tenants, engaged respectively in the business of recycling of waste cooking oil, waste wood, waste metals, waste computer equipment and waste plastics, have already started their operation since April of last year. In addition to that, two recycling centres, run separately by two non-governmental organisations (NGOs), which process waste plastics and waste electrical and electronic equipment (WEEE), began operation in March and October of last year respectively forming part of the EcoPark Phase 2 development.

The "Friends of EcoPark" scheme honours companies and organisations that have built a working partnership with the EcoPark tenants. The partnership can be in the form of waste source supplies; co-ordination of waste collection for the EcoPark tenants; or showing support through the regular uses of recycled products produced by EcoPark tenants.

The scheme is one of the most important events conceived by EcoPark. All companies and organisations that have developed a partnership with any one of the EcoPark tenants is eligible for nomination. Successful nominees are bestowed with a "Friends of EcoPark" certificate and are allowed to use the "Friends of EcoPark" logo to promote their business activities or on their products to signify their awareness as an environmentally conscious corporation. The goal is to encourage different industries in Hong Kong to participate more actively in waste recovery and recycling activities by supporting the EcoPark tenants. Being a "Friends of EcoPark" awardee is a recognition of the corporation's commitment to caring for the environment and its social responsibility as a good corporate citizen. In short, participation in the "Friends of EcoPark" campaign has demonstrated a strong win-win situation for the EcoPark tenants and the participating corporations.





Mr Chan Wan-sang, Tuen Mun district councillor and chairman of its Environment, Hygiene and District Development Committee, who was the honourable guest at the presentation ceremony, said: "the council has been offering its full support to EcoPark since its initial planning stages and will continue to work

closely with it to promote the recycling industry

by encouraging more community involvement." Chan pointed out that there are inherent difficulties in supporting and developing the local recycling industry because of limited volumes of the recyclable materials and the relatively small number of recycling operators in Hong Kong. But he emphasized the Tuen Mun district council will strive to work closely with EcoPark and jointly organise more promotional activities to encourage the participation of the recycling activities by the local community.

As part of the overall presentation ceremony, EcoPark tenants Champway Technology Ltd. (Champway) and Yan Oi Tong EcoPark Plastic Resources Recycling Centre (Yan Oi Tong) also shared in the ceremony their developments of recycling business in EcoPark and the benefits that these partnerships have brought to them.

An awardee of the "Friends of EcoPark" certificate, McDonalds Hong Kong, introduced at the ceremony the company's environmental policy, including the 3Rs (reduce, reuse and recycle) practice, the rechargeable batteries recycling programme and the collaboration with Champway by converting the waste cooking oil arising from the daily operations of their restaurants into clean and usable biodiesel and products.
